| 1.0 | Welcome and Introductions Lucy welcomed all to the meeting and introductions were made. | |

| 3.0 | Minutes of the Previous Meeting and Matters Arising Previous minutes agreed to be a true and accurate reflection of the previous meeting. | |
| 4.0 | <p data-bbox="220 564 1252 631">Delivery Plan The priorities are now listed in alphabetical order and were discussed.</p> <p data-bbox="220 672 1310 985"><u>A - Dangerous drug networks/County Lines/cuckooing and the associated violence</u> Saltash Community school will be hosting "YZUP" parenting sessions on 27.11.18 focusing on harm reduction followed by smaller group sessions after Christmas. There will also be an assembly on 3.12.18 with the Police Youth Interventions Officer regarding the impact of drugs and the legal implications. Consideration will be given, in liaison with the Police on events in 2019. Feedback will be provided as to how the events went and the outcomes.</p> <p data-bbox="220 1025 1310 1160">The school also holds a triage every morning and has great support from local groups such as The Core, Livewire and Junkyard Skatepark. It is also looking to bring in youth workers and is developing a better liaison with the Police to work with troubled children.</p> <p data-bbox="220 1200 1252 1234">Sharps bin for Saltash – it was agreed that this is not a current issue.</p> <p data-bbox="220 1274 1173 1344"><u>B- Domestic abuse</u> A representative for domestic abuse will attend future meetings.</p> <p data-bbox="220 1384 1310 1480">There will be a national domestic abuse awareness raising week at the end of November which will be targeted at businesses. The programme for this is awaited.</p> <p data-bbox="220 1520 1310 1590">Firstlight – Lucy has requested that there should be an event in East Cornwall and will circulate information when available, for all to promote.</p> <p data-bbox="220 1630 1310 1803"><u>C -Suicide attempts off the Tamar Bridge</u> Research has indicated that hand written letters left at hot spots can have a positive impact on prevention and reduce rates. It was agreed that Lucy will establish a working group which will endeavour to engage with the Tamar Bridge and Ferry operator.</p> | Lucy Allison |

D- Crime and Disorder Influence from Plymouth

Plymouth Community Safety Partnership is now a member of Safer Saltash and it was great to have Carl Snell attend the previous meeting.

Shoplifting training provided by D&C Police was discussed and the benefit this could have for Saltash. The Chamber of Commerce will encourage members to take advantage of the initiative. Lucy will liaise with the Police and will circulate information promoting the initiative.

E – Anti-Social Behaviour and Public Disorder on the Waterfront

There was an issue with children tombstoning in the area during the summer months. Jeff mentioned that a focus for this activity is the area owned by Network Rail but there has been a lack of action from them. It was agreed that a letter from Safer Saltash would be sent to Network Rail to seek their action to remedy this issue.

The Core's Friday Night project, which provides a safe space and outreach service, could link into supporting the work on the tombstoning issue.

The issue of older boys and younger girls was discussed and the Police advised it is aware of this and was working on it. Request for all to submit any intelligence to the Police via 101.

Safe Places Cornwall – Police can assist with putting stickers around the town. Mark Rothwell agreed to discuss this with Iain Madden who is leading on the work in Liskeard.

CSAS powers – Jeff attended a session in Plymouth and was impressed. Saltash Town Council have yet to consider implementing this approach and Vashti advised that she will liaise with the Callington Town Council clerk and ascertain if there is any possibility of sharing a resource. Agreed that this would be an agenda item for the next meeting and the clerks from Saltash and Callington town councils would be invited.

F – Comms, Community Engagement and Building Community Resilience
'Have Your Say' survey is now ongoing.

Lucy is awaiting quotes for a leaflet and banner to be used at future events.

A new Comms Plan is being drawn up for the whole of the Safer Cornwall Partnership (which will include/cover each of the Safer Towns). This will be shared with partners once drafted.

Lucy reminded all that there is £5,000 available to Safer Saltash. One possibility could be for Saltash Town Council to consider looking at a project linked to community safety in the town centre which could lead to bringing in CSAS powers.

8.2 Safer Cornwall Training Programme – Offer from Safer Cornwall/DAAT for all Safer Town members to access free training from the team. Lucy will email the list of courses available.

9.0 Emerging Issues

Young volunteers – The Core and Cllr Frank are looking into this and considering Timebanking. Lucy advised that Time Credits are being piloted in Penzance and she will share information she has on this. Saltash Community school is supportive. Lucy agreed to set up a meeting with the Time Credits Project Manager.
