PRAYERS

Prayers were offered by the Mayor's Chaplain.

CHAIRMAN'S REPORT

Councillor Mrs Hooper reported on various visits she had made during the month which included the 20th anniversary of the Wesley, opening the Music, Speech and Drama Festival and attending the Gala Concert, Community Network Area meeting at St Germans, art exhibition at the library for Shelter Box, Burraton Players production, the launch of the gig "Essa" and the Anglican Players Murder Mystery. She had received two cheques from Saltash Has Got Talent, for £500 to the Sue Hooper Charitable Foundation and £500 to the Mayor's Charity Fund Help for Heroes. She had also attended the Plymouth Lord Mayor's Civic Service. She also reminded Councillors of the Showcase event on Saturday and hoped that as many as possible would attend.

Councillor Killeya reported that, as Deputy Mayor, he had attended the Community Network Area meeting, the Community Action through Sports Awards, at which young people were rewarded for their community work and the Volunteer of the Year was from Saltash.

POLICE REPORT

PC Fletcher reported that there had been 51 reported crimes during the month, as compared to 75 for the same period last year. There had been no theft from motor vehicles and only 1 dwelling burglary. The Police have been contacting people who have indicated a willingness to take part in Speed Watch. PC Fletcher stated that the Pillmere roads are to be adopted and, hopefully, work will commence at the end of March and take about six weeks. This will mean that road traffic laws can be enforced. He also reported that the Saltash.net Community School had been burgled and three people have been arrested and property recovered, although there is much damage to the school.

Councillor Ellison stated that there have been quite a few incidences of damage or attempted theft from Cosgrove Construction, but PC Fletcher stated that the Police had not had any reports.

SALTASH GATEWAY COMMUNITY INTEREST COMPANY (CIC)

A copy of the CIC brief for February 2010 had been previously circulated. Two SWOT analysis workshops have been held by representatives of the Fore Street Regeneration Steering Group and the Town Council and they reviewed the Town Projects in the Scott Wilson report, plus the five additional projects identified by the Town Council. The result was that the priority A projects for immediate action were:

- hosting markets,
- the look of Fore Street improving building elevation and fabric and better use of wide pavement areas,
- creation of a civic square.

Project steering groups are now to look at each of those priorities.

Cornwall Council's Business Improvement District (BID) Development Officer gave CIC Directors a presentation on a district scheme. The presentation notes had been forwarded to the Town Clerk and it was **RESOLVED** that a copy is forwarded to all councillors.

Mr Williams reported that the CIC office has been handed back to Cornwall Council, but they still have use of it for meetings. Councillor Ellison enquired if the Scott Wilson database of owners of shops in Fore Street was available, and Mr Williams said this was part of the appendices, but has not been circulated. Councillor Mrs Hooper enquired if the report by Sam Cleave on transport is to be made more publicly available. Mr Williams stated that it is intended to be more fully discussed at a debriefing on 24th February.

PRESENTATION BY NETWORK RAIL

It is hoped tenders for the painting of the Royal Albert Bridge will go out in mid-April and a tender will be awarded in August. Scaffolding will be put up from mid to end of October 2010 and it will be a two year project, ending in March 2013. It is to be a major refurbishment, costing in the region of £15 million, and any defects in the steelwork are to be repaired. Also some steel bars added in the 1970's are to be removed. During the period of work the trains will mainly run as normal and any disruption will be kept to a minimum. Work is being undertaken to the main strands and not to the approaches. The final say on colour will rest with English Heritage.

Councillors raised the condition of the Culver Road bridge, but it was stated this is not within the project, but there will be a programme somewhere in which repairs should be included.

Councillor Gee stated that he was concerned about waste and noise at night. The representatives of Network Rail stated the scaffolding will be erected at night and contractors and sub-contractors will be told to behave and Network Rail will take these issues seriously. There will be a Helpline and this will be issued before the work starts. Councillor Ellison asked that, at the end of the works, would Network Rail consider putting in discreet lighting. Whilst his is not in the scheme at the moment, they will have a look at this. The bridge will be encapsulated in plastic, but should the wind speed reach 100mph, then they will have to cut the encapsulation. In an indicative straw poll there were seven votes for painting in the white stone paint and three votes for the grey. Councillor Bickford asked if another public meeting could be arranged and he will look into this via Saltash Rail Users Group (SRUG).

CORNWALL COUNCIL REPORT

Councillor Austin reported that the main topic has been the budget, which will show a rise of 2.9% or £1,400 on a Band D property. All sections will be reduced, except frontline services, and Councillors' allowances have been frozen. The £2,120 given to Councillors for community grants will be carried forward into the next financial year, when each will also receive £8,000 for highways. He stated that it now looks as though the Traffic Regulation Orders will be delayed until April 2010 and thereby leaving the £2,000 intact for community grants. Councillor Killeya enquired how the Council would access the community grants and it was **RESOLVED** that this is discussed at the Policy and Resources Committee.

Councillor Holley referred to the adoption of roads on Pillmere and he stated that this will not necessarily resolve all the issues on the estate and the Town Council should start thinking about sorting out the play parks. There is no money left for the maintenance of the whole area. It was **RESOLVED** that a discussion on provision of parks at Pillmere is added to a future Civic Amenities agenda.

Councillor Holley was concerned at the centralisation of services in Cornwall as the services at Luxstowe House are gradually being taken out, i.e. leisure services and car parks to Bodmin. Councillor Riches stated that the Legal Officer for Cornwall is very keen that the residents of Pillmere should set up a community interest company themselves to maintain community spaces. Councillor Riches has voiced his opinion that it is double taxation and it should not happen. There was a heated debate at Cornwall Council about cutting Child Services and the recommendation has been reversed, and there will now, therefore, be no cut.

Councillor Austin said that in the budgetary process, it should be noted that the range of percentage increases in Town and Parish Council budgets ranged from 0% at Torpoint to 21% at Newquay.

Councillor Killeya stated that the One Stop Shop staff had invited the Town Council to visit but a date had not yet been set and he will follow this up.

Councillor Mrs Hooper referred to the fencing at Warfelton above Church Road and asked if the company is legally bound to keep the fencing there. Councillor Austin stated that the company has to wait two years as an application form has been requested to apply for village green status.

(Councillor Bickford left the meeting.)

Councillor Mrs Merryn Killeya stated that people are getting in over the fencing and there was a discussion on what could be done to stop this.

(Councillor Bickford returned to the meeting.)

It was **RESOLVED** to check with Cornwall Planning to ask if an application should come in for the fencing and also to write to the Housing Association to find the current position regarding the fence.

QUESTIONS

(a) Mr Anstey enquired if the lighting at Pillmere will be completed, together with the two bridges. Councillor Riches replied that he will be taking this up and the bridges have been discussed already at the Civic Amenities Committee.

- (b) Mr Anstey reported that the wooden fencing by the play area on Pillmere is in disrepair and Councillor Riches stated that he has taken this up, but he will follow up again.
- (c) Mrs Mary Marnell thanked that Council for the events to which the May Fair Princess and attendants have been invited during the year.
- (d) Miss Miller asked what had happened to the litter bin by the Dock Dung seat and Councillor Austin stated that this is on the agenda of the Industry, Commerce, Transportation and Tourism Committee for discussion on Monday.

Councillor Gee declared a personal and prejudicial interest in Elwell Woods and will leave the meeting during discussion, as he is Treasurer of Saltash Waterfront Residents' Association (SWRA), which has made the application. Councillor Bickford declared a personal and prejudicial interest in the same Minute as a member of SWRA, and Councillor Ellison also declared a personal and prejudicial interest in the Minute as he is the applicant, on behalf of SWRA.

Councillor A Killeya declared a personal interest in items regarding Fore St regeneration as a member of CIC.

Councillor Clements declared a personal and prejudicial interest in planning application number 10/00036/FULR, The Boathouse, Anthony Passage, and he will leave the room after speaking, as he is the applicant of the Footpath Modification Order.

Councillor Oakes declared a personal and prejudicial interest in Minute number 209/09/10(d), planning application re 9 Dunheved Road as it is a neighbouring property.

Councillor Mrs Hooper declared a personal interest in planning application number 10/00158/FULR, The Old Drill Hall, Elwell Lane, as the applicant is known to her. She also declared a personal interest in planning application number 10/00036/FULR, relating to The Boathouse, Anthony Passage, as two of the objectors are known to her. Councillor Mrs Hooper also declared a personal and prejudicial interest in the payment to the Saltash Music, Speech and Drama Festival of $\pounds1,000$, as General Secretary of the festival.
