Cornwall Core Strategy

The Chairman drew members attention to the Cornwall Core Strategy Consultation which will set out aims and planning policies for Cornwall up to 2030 taking place at the Guildhall on 13th January 2012 and the need to attend and give support for the lower preferred option of 1,000 houses as opposed to the counter option of 3,500 houses proposed for housing development.

It was **RESOLVED** that:

1. Members gather support and attend to put forward the view for the lower preferred option for housing.
2. The strategy be an agenda item for the Full Council meeting to be held on 3rd February 2012 to consider the council response.
3. A letter be sent to Cornwall Council to determine who has put forward the counter option figure of 3,500 houses.
