

# Consultation for Cornwall Site Allocations Development Plan Document: Schedule of Modifications

Dear Consultee,

I am writing to inform you that Cornwall Council has published the following document for a six week consultation period.

**Cornwall Site Allocations Development Plan Document (DPD): Schedule of Proposed Modifications** (Town and Country Planning (Local Planning) (England) Regulations 2012)

**The consultation is open from 10 September to 5pm 22 October 2018.**

Late representations will **not** be accepted.

The Allocations DPD is in the middle of an Examination in Public. During the Examination Hearings a number of alterations have been proposed and these are set out in the **Schedule of Proposed Modifications**. The Inspectors appointed to examine the document have now instructed the Council to consult on these proposed modifications.

Unlike previous consultations, we are only seeking comments focused on the Schedule of Proposed Modifications and the evidence documents that support those modifications.
