**290/18/19 TO CONSIDER A VOTE OF NO CONFIDENCE IN COUNCILLOR BRADY TO CONTINUE TO UNDERTAKE THE DUTIES OF CHAIRMAN OF SALTASH TOWN COUNCIL AND MAYOR OF SALTASH. DATED 16<sup>TH</sup> OCTOBER 2018**

Proposal from Councillor Miller and Seconded by Councillor Pinckney:

It was with regret that I submitted the request for an Extraordinary Town Council meeting to consider a vote of no confidence in the Mayor of Saltash, Councillor John Brady. I had become very concerned about the autocracy of contentious decisions being made, the undemocratic way in which they were being implemented, and the increasing amount of time and energy being needed to try and have these reconsidered.

The matter of the use of the Mayoress's chain being proposed to be reinstated without debate of the options was not a good sign back in May, followed by a unilateral decision to deploy wardens as Security Enforcement in Fore Street. He has gratuitously offended many people – including Councillors – with increasing frequency, bringing his integrity into question. He also has a number of unresolved Code of Conduct issues, which doesn't show the ability for conciliation.

I began consulting colleagues for their opinions several weeks ago, although at that time it was felt that there was still hope to resolve the situation internally. The Mayor proposed a "clear the air" meeting which was dogmatically scheduled for a time very inconvenient to many members with a refusal to reconsider the timing – and then we had bunting-gate.

This particularly involved ward members spending significant time in totally unnecessarily preparing and presenting objections and justifications for a change of decision, and eventually where the Chairman of Staffing also felt it necessary to intervene in opposition to the Mayor's directives. Rather than accept an error and apologise for his mistake, he simply resigned as Chairman of Services Committee!

All this wasted effort achieved nothing in terms of addressing the substantial amount of Council business which needs to be undertaken and began significantly impinging on staff time spent investigating legalities. It was also the first incident to directly involve the public-facing aspect of council activities, resulting in a petition from residents, and an awareness of internal problems which were unsustainable, including the Town Clerk and Wardens in particular being severely compromised.

Although my submission for this meeting and vote was originally made on the day that the lack of Remembrance Parade became widely realised, it was purely coincidence and that issue itself is merely a symptom of the situation which has developed from almost that start of Councillor Brady's tenure as Mayor, and I consider untenable.

Although being intelligent and having a good and innovative ideas, Councillor Brady has a history of confrontational actions. Before being elected he was asked of his attitude to Chairmanship of the Council and gave assurances that he would seek to engender a spirit of teamwork and cooperation and participate in community activities in the traditional way. Ultimately actions speak louder than words, and we have had too many undelivered promises about meaningful discussion and consensus for me to believe things will actually change. I thereby submit this motion for consideration by Councillors.

Chairman's response:

Saltash Town Council had been run for a number of years on Custom and Practice with no processes or procedures in place. Since I became Mayor, Saltash Town Council is adopting a new committee structure, reviewing policy and procedures and for the position of Mayor only a protocol document was in place. There was no specific laid down duties for Mayor in Standing Orders. Also, the Business Strategy and Forward Planning committee will be reporting on November 1<sup>st</sup>.

Councillors Bickford, Parker and Taylor also left the meeting.
