2019 Off-Street Parking Order

I am writing to advise of the public consultation which is taking place concerning our car parking proposals across Cornwall Council-owned car parks, which if approved will be implemented on 01 April 2019. Included in this are changes to the permit options that will be made available to Reserved Permits.

The changes to the permit options are being proposed following lengthy discussion with Local Members and communities who have been calling for a system which will help to ensure reserved spaces are leased to those who will gain the most use. Evidence has shown that in a lot of our car parks, spaces are empty for lengthy periods of the year and yet there are a high number of local residents and business owners having great difficulty finding parking that are on our waiting lists for significant times.

To try and resolve the issues raised to us by many, we propose to implement a new permit purchase system for reserved space holders. If implemented there would be four permits space holders can choose to purchase, dependant on what most suits your needs. One of the tickets would be available without Vehicle Registration Marks (VRM's) printed on it; the other three would require you to advise us of the vehicle/s you wish to park in your space.

Please note that in locations where we have existing policies of eligibility criteria's for spaces i.e. where lease holders must either be a resident or business within a specific catchment area, we propose a restriction on the purchase of Ticket Type Four. These are:

- 1) All St.Ives and Newlyn reserved car parks Ticket Four will only be available to those who can evidence that they are paying Business rate Council Tax
- 2) Duck Street, Mousehole and Castle Green, Helston Ticket Type Four will not be available at all.

Below are outlined the specifics with regard to the permit type you currently purchase and how these changes are likely to affect you. In terms of permit costs, you will see that for three of the permit types we propose to either lower the fee, or keep it the same as you are currently paying.

Proposed No VRM

£400.00
