The Chairman informed members that STC have received several questions relating to the Precept increase for 2019-20 and read the following statement:

Thank you to those who have sent specific questions relating to the Precept 2019-2020. The precept was set after long discussions at Committee levels and ratified as the Council Precept at Full Town Council 6th December 2018.

Our Council put out fliers, explaining the increase and rationale behind the increases and a summary has been put out regarding specific increases. I have invited a number of Councillors to prepare a reasoned paper for the increases and meet with me on 27th March for inclusion in the April Messenger column in the Observer. Councillor Bickford has today issued a press release relating to the Station refurbishment/contract signed and Saltash Town Council (STC) will continue advertising projects as they evolve.
