**TO CONSIDER THE CHILDRENS FUND FOR ENGLAND**

The board were informed of the new Children's Funeral Fund for England which has been established to ensure no parent will have to pay for their child's burial or cremation, if under the age of 18 years old, by allowing parents to claim these costs back from the Government.

It was added that currently Saltash Town Council do not charge for any child resident to be buried or cremated and were going to continue with the existing policy and not adopt the new Fund for England. All agreed this policy would be reflected at St Stephens Cemetery.

It was **RESOLVED** the new Children's Funeral Fund not to be adopted and St Stephens Cemetery to continue not charging for burial services for a child resident of Saltash under the age of 18.
