2020 Off-Street Parking Order

I am writing to advise of the public consultation which is taking place concerning our car parking proposals across Cornwall Council-owned car parks, which if approved will be implemented on 01 April 2020. Included in this are changes to the cost of reserved parking spaces.

Car Park:	Alexandra Square, Saltash - Reserved
Proposed 1 VRM	£284.08
Proposed 2 VRM	£319.59
Proposed 5 VRM	£355.10
Proposed No VRM	£406.00
