### **EDG1685 Cornwall Gateway Year 2 Community Network Scheme**

Cormac Solutions Ltd on behalf of Cornwall Council is inviting comments on a proposal to introduce a 20mph speed limit in Hatt, and to extend the existing 20mph speed limit at Old Ferry Road, Saltash to include Tamar Street, Brooke Close and Town Quay. Both proposals will be supported by various traffic calming features and amendments to waiting restrictions (see drawing ref. EDG1685 SN01/SN02 for details).
