

Safer Saltash Briefing Notice

Please see brief Safer Saltash meeting summary and actions from the previous two meetings, the next meeting is scheduled for tomorrow **Thursday 22nd October at 13.30pm**. Glenn Bullock (Highways England) will be attending the next meeting to discuss a dash cam initiative involving businesses covering A38 from Saltash to Bodmin.

06.10.20

- Safer Saltash article in the Observer (page 4 on attached) – thank you Cllr Frank for this
- Safer Saltash update provided to Saltash Town Council and will be uploaded to website – thank you Cllr Lennox-Boyd and Cllr Rance
- Update provided on the temporary road closure at Saltash Community School; meeting arranged with the school, CC transport and Cormac plus Cllr Frank to review how effective the temporary road closure has been. There is no suggestion that the closure will end but it provides an opportunity to check its working as well as hoped and if any changes are needed. Meeting planned for Tuesday 20th Oct.
- Police licencing have followed up on concerns with specific licenced premises
- No issues at football match last weekend
- Masks – down to individual shops to manage themselves. Concerns raised with a specific shop not enforcing masks and Helen Toms offered to contact the Regional Manager to ask about their policy on masks
- Several areas where speeding is an issue raised to police by Cllrs; police team agreed to visit hotspots roads as and when demand allows
- Children's Centre not open yet – will be shortly
- Livewire secured funding for new mood tracker app for young people – will send trigger to Livewire if mood drops significantly so they can make contact with young person
- No waterside issues with ASB now schools gone back, and the weather has changed

17.09.20

- ASB at The Green, Fairmead Mews - Mary has visited, CCTV is being obtained. No known individuals but large numbers of children playing for prolonged periods.
- Groups congregating drinking, lighting fires/BBQs and litter at Nature Reserve – Lucy passed logs to Fire for a visit. The area is not covered by PSPO (but if under 18 it doesn't matter as alcohol can be removed). PC Morris did foot patrol. Seems to be sporadic. Potential future PSPO to cover the nature reserve – not able to progress this due to low number of reports and lack of evidence of significant harm/distress being caused to many. Helen Toms agreed to feed this back to Bob Austin. If the ASB here escalates or involves

people over 18 this could be reconsidered if there are enough logs/reports to substantiate the level of harm.

- ASB on the Waterfront - Postponed plans for early Summer 2020 to address the ASB on the waterfront seasonal issues to be carried forward to 2021. PC Lavers spoke to Livewire. Complaints reducing significantly. Joint ASB and Police patrols taking place
- Private Facebook Group - We discussed the Facebook group 'Saltash Against Crime' and agreed there is a general frustration amongst residents. Brief on Safer Saltash and an update on what we are doing prepared and circulated.
- Police update- crime rates are stable, there are 2 suspects on bail for the armed robbery – both apprehended very quickly
- Details on a specific CBO circulated
- Traffic and the safety of young people at school drop off/pick up times discussed. Catherine Thomson is liaising with the schools to reach a solution and provide support
- Cornwall Housing – Donna has a budget for improvement works. Suggestions to Donna McEvoy please
- Saltash Christmas Festival and Lantern Parade cancelled this year due to C19 restrictions; as an alternative Saltash will be encouraging window displays and an outdoor art gallery. Lucy agreed to facilitate a Safer Saltash window display in one of the unused shops on Fore Street and suggested a festive alcohol theme (harm reduction messaging).

ICA Development Survey
