Overlooking by upper windows on amenity space of houses in St Stephens Road. 2. Pedestrian safety and access (especially as pedestrians would have to stray onto private property to avoid vehicles). 3. Loss of business land. 4. Overdevelopment of site.

5. Density and design is out of character with street scene.
6. Poor access for vehicles especially emergency vehicles which would have to park in Callington Road.
7. Insufficient parking.
8. Lack of turning space and therefore poor access for refuse services (which cannot be expected to reverse out).
9. Lack of Amenity space.

URGENT NON-FINANCIAL ITEMS AT THE DISCRETION OF THE CHAIRMAN

1. Date of next meeting.

Members considered the issue of the Guildhall being required as a polling station on the 5th May 2011, the scheduled date of the next meeting.

It was **RESOLVED** that the next meeting of the Full Council be held on 4th May 2011 (subject to the availability of the Guildhall) and that the press and public be notified accordingly.

2. Promotional activity in Fore Street.

Members considered a request from Cornwall Highways regarding a

promotional company wishing to park a display vehicle in Fore Street within the next four weeks until the end of July.

It was **RESOLVED** that the request be approved subject to:

1. The dates of 29th April, 30th April and 1st May not being approved due to the Mayfair weekend activities.
2. The most suitable locations being outside Superdrug/Job Centre with the permission of the owners.
3. The vehicle/display does not constitute an obstruction or impede movement on the pavement or highway or affect any access or egress to associated properties.
4. It is not located on any green spaces.
5. That an appropriate sum is contributed to the Town Council town centre development fund.

3. Unitary Devolution

The Chairman informed members that recent information he had received indicated that Cornwall Council were seeking business package applications from local councils for the devolution/transfer of its services, land and buildings.

The Chairman referred to a letter of request he had previously sent to Cornwall Council, outlining land and services that the Council had agreed in principle it would be interested in taking over; however, to date delays had been experienced with Cornwall Council in progressing individual item requests for transfer.

It was **RESOLVED** that the item be considered at the next meeting of the Policy and Resources Committee, as an urgent non financial matter at the discretion of the Chairman, to consider the submission of a package of services and land the Council would be interested in assuming responsibility for.
